

**BFREE FOODS – “TRAVEL WELL AND EAT HAPPY” GIVEAWAY
TERMS AND CONDITIONS**

ENTRANTS MUST BE 18 YEARS OF AGE OR OLDER TO PARTICIPATE. NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING.

DESCRIPTION:

The BFree Foods- “TRAVEL WELL AND EAT HAPPY” Giveaway (the “Giveaway”) will award one winner a prize package that includes a two night stay at The Inn Berlin (valued at \$750), (\$800 travel voucher) and a hamper of prizes from BFree Foods.

The runner up will receive the following: A hamper of delicious products from BFree Foods and BFree branded merchandise (hat and tote).

The two night stay at The Inn Berlin and travel voucher must be redeemed by July 1, 2027

ELIGIBILITY:

The Giveaway is open only to legal residents of the United States and the District of Columbia, excluding its territories and possessions, age 18 or older at the time of entry. Void where otherwise taxed, prohibited or restricted by law.
